2019 Legislative Priorities Presented During Kentucky Chamber Visit to London

The Kentucky Chamber's visit to London is part of a statewide tour to share information with local communities and chambers of commerce about key business issues the state Chamber will focus on during the session that begins in January.

Adkisson's presentation focused on the following issues:


