SAINT JOSEPH LONDON

Saint Joseph London has a long history serving Laurel and surrounding counties. Founded in 1926, the current regional hospital opened in 2010 and provides all private patient rooms, with most overlooking a small lake and garden on the 52-acre healing environment.

The hospital continues to grow.

In January, Saint Joseph London celebrated the addition of its newest service line - Comprehensive Wound Care - with a ribboncutting celebration and open house. To make it easier for the community to meet their health care needs, a new two-story, 60,000 square foot medical office building is being built on the campus. The building will be home to physicians from the CHI Saint Joseph Medical Group.

The Saint Joseph London Foundation is working to raise \$1.4 million to develop a Level II Neonatal Intensive Care Unit (NICU) at the hospital. The new NICU will provide intensive care services to infants and will allow the parents of fragile infants to stay by their side as they receive specialized treatment in their local hospital. This year's Foundation Gala raised \$50,000 for the unit, and the Foundation has received a \$63,000 gift from the WHAS Crusade for Children for the project.

Saint Joseph London has been recognized for the quality care it provides. The hospital was named a Blue Distinction Center for Maternity Care by Anthem Blue Cross and Blue Shield and received CAP Accreditation by the College of American Pathologists.

Saint Joseph London is part of CHI Saint Joseph Health, a comprehensive health system with 135 locations throughout central and eastern Kentucky, including hospitals, physician groups, clinics, primary care centers, specialty institutes and home health agencies. The system provides strong community support with various community activities and events, addressing such important issues as child abuse and human trafficking. Last year, community health workers at Saint Joseph London developed a community garden, providing fresh vegeta-

bles to patients and to community members who volunteered to help in the garden.
