Primary Election - June 23

We wanted to share this **important information** about the upcoming primary election on June 23, 2020 for Laurel County Residents:

Vote in person at North Laurel High School or South Laurel High School. Either is fine, you don't need to vote at the school in your district.

Vote in person **EARLY** at the Annex Building behind the courthouse through June 22nd. Open Monday - Friday 8 am to 4 pm.

In person Absentee Ballot—to request a ballot visit https://vrsws.sos.ky.gov/
ovrweb/govoteky once you have completed your ballot you can drop it off at the Clerk's office in a secure box to be counted.

Mail in your ballot by again requesting a ballot at https://vrsws.sos.ky.gov/ovrweb/govoteky. Once you receive the ballot it will have a postage paid envelope to return it.
