SBA Adds Additional County to Eastern Kentucky Disaster Declaration and Extends Business Recovery Center Hours

ATLANTA – The [U.S. Small Business Administration \(SBA\)](#) announced today that **Owsley County** is now included as a primary county in the disaster declaration in Eastern Kentucky for the severe storms, flooding, landslides and mudslides that began July 26. The SBA is also extending the hours of all its Kentucky Business Recovery Centers (BRCs) from 9 a.m. to 7 p.m. daily, beginning Saturday, Aug. 6.

The disaster declaration covers Breathitt, Clay, Floyd, Knott, Letcher, **Owsley**, Perry and Pike Counties in **Kentucky**, which are eligible for both Physical and Economic Injury Disaster Loans from the SBA. Small businesses and most private nonprofit organizations in the following adjacent counties are eligible to apply only for SBA Economic Injury Disaster Loans (EIDLs): Bell, Harlan, Jackson, Johnson, Knox, Laurel, Lee, Leslie, Magoffin, Martin and Wolfe in **Kentucky**; Buchanan, Dickenson and Wise in **Virginia**; and Mingo in **West Virginia**.

The SBA’s Business Recovery Centers are open as indicated below until further notice:

Customer Service Representatives will be available as indicated above at the BRCs to answer questions about the disaster loan program and assist business owners in completing their applications. Due to the ongoing COVID-19 pandemic, the SBA has established protocols to help protect the health and safety of the public. All visitors to the BRCs are encouraged to wear a face mask.

Businesses and private nonprofit organizations of any size may borrow up to \$2 million to repair or replace disaster-damaged or destroyed real estate, machinery and equipment, inventory, and other business assets. Applicants may be eligible for a loan amount increase of up to 20 percent of their physical damages, as verified by the SBA, for mitigation purposes. Eligible mitigation improvements may include a safe room or storm shelter, sump pump, elevation, retaining walls, and landscaping to help protect property and occupants from future damage caused by a similar disaster.

For small businesses, small agricultural cooperatives, small businesses engaged in aquaculture and most private nonprofit organizations, the SBA offers [Economic Injury Disaster Loans \(EIDLs\)](#) to help meet working capital needs caused by the disaster. Economic Injury Disaster Loan assistance is available regardless of whether the business suffered any physical property damage.

Disaster loans up to \$200,000 are available to homeowners to repair or replace disaster-damaged or destroyed real estate. Homeowners and renters are eligible for up to \$40,000 to repair or replace disaster-damaged or destroyed personal property.

Interest rates are as low as **3.04** percent for businesses, **1.875** percent for nonprofit organizations and **2.188** percent for homeowners and renters, with terms up to 30 years. Loan amounts and terms are set by the SBA and are based on each applicant's financial condition.

To be considered for all forms of disaster assistance, applicants should register online at [DisasterAssistance.gov](#) or download the FEMA mobile app. If online or mobile access is unavailable, applicants should call the FEMA toll-free helpline at 800-621-3362. Those who use 711-Relay or Video Relay Services should call 800-621-3362.

Applicants may apply online using the Electronic Loan Application (ELA) via SBA's secure website at <https://disasterloanassistance.sba.gov/ela/s/> and should apply under SBA declaration # 17546.

The physical loan application deadline is **Sept. 28, 2022**. The deadline to return economic injury applications is **May 1, 2023**.
